# To Nordhavnen's guest sailors with a yellow label

(1. april 2023 - 31. marts 2024)

#### **Dear Guest Sailor**

You have had a yellow label because you are staying in Nordhavnen for a longer period. In this letter, you will find important information about the prices and rules of the harbour.

### Our prices during summer and winter

From 1. April until 30. September the daily rate for guest boats is as follows:

up to 10 m in length kr. 160,00 incl. VAT up to 12 m in length kr. 195,00 incl. VAT up to 15 m in length kr. 240,00 incl. VAT over 15 m in length kr. 440,00 incl. VAT

If you are staying in Nordhavnen for an entire month during summer, we will offer you a 12-days discount. Please notice that the discount only applies, if the payment is done in time before the end of the month. If you are leaving Nordhavnen for a long summer tour, you must announce it at the Marina Office before the departure. We will give you the lowest possible price while you are away.

From 1. October until 31. March you pay our winter fee which is the boats length x width x 375,83 kr.

#### **Payment**

Your payment must be done at the last workday of the month, and you yourself are responsible for paying on time. As a guest sailor with a yellow label, you will not be sent an invoice from the Marina Office.

You can pay by a banktransfer to reg. nr. 9035, konto 457 36 14521 (allow one day for the transfer) or you pay on MobilePay at 423674. In both cases, you must write your guest number (the number on your yellow label) on the payment. If none of these two ways of paying is possible for you, you can pay by cash or card at the Marine Office during opening hours.

In case of late payment you will be send a reminder and a fee of 100 kr. per time is charged in addition to the amount owed.

## Rules during your stay in the harbour

You can use all empty places marked with green signs. It is also possible to use the guest moorings without numbers. Please do not use a large place for a small boat, but find a place that fits the size of your boat.

When you are in the harbour, the sign must be kept on green. You may only turn the sign on red, if you go on a one-day trip without overnight stay. When the boat leaves the port for the rest of the season, this must be notified to the Marina Office.

You must always be able to move your boat with 24-hour notice. If, exceptionally, this will be impossible for you, the port staff will be happy to assist, but the move is at your own responsibility and risk, end we will charge you a service fee.

It is not legal to take permanent living in a boat with a yellow guest number, and you cannot have you address on the boat. Circumvention of this rule may result in expulsion from the harbour.

Please notice that guest boats can only be landed by prior agreement with the Marina Office.
